### Section 95A of the Resource Management Act 1991

The Hastings District Council has received an application from The Te Mata Mushrooms Company Ltd for a resource consent to Increase the Intensive Rural Production (IRP) of Mushrooms at Te Mata Mushrooms, Brookvale Road, Havelock North. The Council has determined that the application must be publicly notified in accordance with Section 95A of the Resource Management Act 1991.

**Description of Proposal:** Land use consent to increase production of mushrooms from 25 tonnes per week to 100 tonnes per week, including:

- increasing compost production up to 500 tonnes per 7-day period;
- extending existing (Phase 1) bunkers and constructing a new building (adjacent to Phase 2 tunnels);
- constructing a concrete pad in centre of site; and
- retrospective consent for construction of a recycled water/oxidation pond

The subject site is zoned Plains Production and contains Scheduled Activities Site S37 (applies to Lot 2 DP 7771 and Lot 3 DP 28543 only) in the Proposed Hastings District Plan (As Amended by Decisions 12 September 2015). The proposal requires resource consent as a **non-complying activity**.

## Submissions:

Any person may make a submission on the application, but a person who is a trade competitor of the applicant may do so only if that person is directly affected by an effect of the activity to which the application relates that –

- (a) adversely affects the environment: and
- (b) does not relate to trade competition or the effects of trade competition

You may make a submission by sending a <u>written or electronic</u> submission to the Hastings District Council, Private Bag 9002, Hastings 4156. The submission must be on or in the format of 'Form 13' of the Resource Management (Forms, Fees and Procedure) Regulations 2003. The submission must include the following information:
