IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by **Giant Brewing Company Limited** for an Off Licence pursuant to s.100 of the Act in respect of premises situated at 5 Donnelly Street, Havelock North known as Giant Brewing Company.

DECISION

This is an application by **Giant Brewing Company Limited** for an Off Licence in respect of premises situated at 5 Donnelly Street, Havelock North, known as Giant Brewing Company.

Reports were received from the Police, Medical Officer of Health and Licensing Inspector indicating no objection to the application.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

The Committee has considered the matters to which it is to have regard under section 105 of the Act and is satisfied that these are met. Accordingly the applicant is hereby granted an off licence for a period of one year.

CONDITIONS

This licence is subject to the following conditions.

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.**
- (b) Alcohol may be sold only on the following days and during the following hours:**

Tuesday to Saturday 12.00 midday to 8.00 pm.
- (c) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.**
- (d) Drinking water is to be freely available and free of charge to customers at the following location while alcohol is being supplied free as a sample on the premises: In each area where free alcohol samples are provided.**
- (e) The licensed area is described in the plan stamped as received on 3 December 2017.**
