IN THE MATTER of an application by **Giant Brewing Company Limited** for renewal of an on-licence pursuant to s.127 of the Act in respect of premises situated at 9 Napier Road Havelock North, known as **Giant Brewing Company**.

DECISION

This is an application by **Giant Brewing Company Limited** for the renewal of an on-licence in respect of premises situated at **9 Napier Road Havelock North**, known as **Giant Brewing Company**.

The premises operate as a Tavern.

Reports were received from the Police, Medical Officer of Health and Licensing Inspector indicating no objection to the application.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

The Committee has considered the matters to which it is to have regard under sections 105 and 131 of the Act and is satisfied that these are met. Accordingly the applicant is hereby granted the renewal of an on-licence in respect of the premises known as Giant Brewing Company Limited for a period of three years from the date of expiry.

CONDITIONS

This licence is subject to the following conditions:

- a. **No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not:**
 - i. **residing or lodging on the premises; or**
 - ii. **present on premises to dine.**

- b. **Alcohol may be sold only on the following days and during the following hours:**

Main premises - Monday to Sunday	11.00 am to 12.00 am Midnight
Front footpath dining area - Monday to Sunday	11.00 am to 10.30 pm

- c. **The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.**

- d. **The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.**

- e. **Drinking water is to be freely available and free of charge to customers at the following location while the premises are open for business: In the lounge and at the bar**
- f. **The host responsibility policy supplied with the application is to be fully complied with.**
- g. **Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.**
- h. **The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low alcoholic beverages.**
- i. **The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from licensed premises.**
- j. **The entire premises is designated as: Supervised**
- k. **The licensed area is described on the plan date stamped: 6 July 2020**
