**4.0 INITIATIVES**

**4.1 Online applications**

4.1.1 All Alcohol licence applications are done online and there is now a client dashboard for all premises, managers and customers to see where in the process there applications are.

## **5.0 LOCAL ALCOHOL POLICY (LAP) UPDATE**

### **5.1 Does the TA have a LAP?**

- 5.1.1 There is currently an adopted LAP in force for our District. It is a combined LAP with Napier City Council.

### **5.2 What effect do you consider your Local Alcohol Policy is having?**

- 5.2.1 It has slightly reduced the hours for most off licenses and enforced a one way door for on licenses at 2am.
- 5.2.2 The biggest effect has been the LAP has protected some of our most vulnerable areas in the district by having a location control; not allowing further off licences (Bottle stores) to be held in certain areas.

### **5.3 Is your Local Alcohol Policy due for review?**

- 5.3.1 The LAP is not due for renewal until either 2022 or 2025. Collaboration with both police and health are occurring in the interim to assess the impact the policy is currently having on the district. A full Council committee will decide in 2022 whether a review will be completed at that point or at the six year maximum review period under the Act.

## **6.0 OBJECT OF THE SSAA 2012**

### **6.1 Please comment on the ways in which you believe the Sale and Supply of Alcohol Act 2012 is achieving its object. Note: the object of the Sale and Supply of Alcohol Act 2012 is that:**

*the sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and  
the harm caused by the excessive or inappropriate consumption of alcohol should be minimised.*

- 6.1.1 The Act is achieving its object by providing rules for premises and events to reduce harm. The SSAA 2012 has provisions which the DLC's can use for higher risk premises and events that are appropriate at a local level.
- 6.1.2 Provisions in the Act that allow for the consideration of trading hours provide an opportunity to place restrictions on the sale and supply of alcohol, this in turn assists in reducing harm. Other examples include, the ability DLC's to implement additional discretionary conditions on special licences to ensure the sale, supply and consumption of alcohol is undertaken safely and responsibility; placing limitations on the amount of drinks sold in one transaction; providing for security measures and the requirement for Alcohol Management Plans to name a few.
- 6.1.3 However, academic research shows that price and age are two areas that can make the biggest difference to alcohol related harm and these are outside of the control of local government and beyond the remit of the Act. Therefore there will always only be limited ability to truly minimise harm caused by alcohol consumption.

**6.2 To what extent, if any, do you consider that achievement of the object of the Act may have been affected by the Covid-19 pandemic?**

6.2.1 The majority of premises were not open so therefore the object of *'the sale and supply should be undertaken safely and responsibly'* is largely not applicable. The supermarkets continued to control supply and abide by the rules and regulations of the Act. Customers purchasing habits largely changed to reflect the inability to purchase alcohol elsewhere (bottle stores and on licences).

6.2.2 Customers consumption habits moved to be in the home rather than in on licence premises. The issue with in home consumption is having no control over consumption levels and serve sizes which may or may not have effected harm levels during the pandemic. Academic research would suggest that as availability changes (only having supermarkets open for sales) patterns of consumption just change and people adapt.

We did see a push from premises to try to move to a remote sales or largely internet based selling process. This put pressure on inspectors to answer a surge of enquiries about changing to a remote sales licence; trying to sell alcohol online or for on licences to sell alcohol as a off licence in the interim.

6.2.3 The pandemic has required many premises to diversify there businesses or have a larger online presence.

6.2.4 However I do not have evidence of whether the pandemic has had a impact on achieving the object of the act.
