4. Please comment on any changes or trends in the Committee's workload in 2020-2021.

5. Please comment on any new initiatives the Committee has developed/adopted in 2020-2021.

None.

6. Has your Committee developed a Local Alcohol Policy?

There is currently an adopted LAP in force for our District. It is a combined LAP with Napier City Council.

7. What effect do you consider your Local Alcohol Policy is having?

It has slightly reduced the hours for most off licences and enforced a one way door for on licences at 2am.

The biggest effect has been the LAP has protected some of our most vulnerable areas in the district by having a location control that does not allow further off licences (in relation to bottle stores) to be issued in certain areas. The one way door has also been effective in reducing harm and flow from one premises to another later in the evening.

8. When is your Local Alcohol Policy due for review?

The LAP is not due for renewal until August 2025. Collaboration with both Police and Health is occurring in the interim to assess the impact the policy is currently having in the district.

9. Please comment on the manner in which Covid-19 has impacted on DLC operations.

During the lockdown the number of applications for new managers certificates and licences decreased and subsequently impacted on the number of renewals that would have been associated with these applications.

10. Please comment on the ways in which you believe the Sale and Supply of Alcohol Act 2012 is, or is not, achieving its object. Note: the object of the Sale and Supply of Alcohol Act 2012 is that:

- a) the sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and***
- b) the harm caused by the excessive or inappropriate consumption of alcohol should be minimised.***

The Act is achieving its object by providing rules for premises and events to reduce harm. The SSAA 2012 has provisions which the DLC's can use for higher risk premises and events that are appropriate at a local level.

Provisions in the Act that allow for the consideration of trading hours provide an opportunity to place restrictions on the sale and supply of alcohol, this in turn assists in reducing harm. Other examples include, the ability of DLC's to implement additional discretionary conditions on special licences to ensure the sale, supply and consumption of alcohol is undertaken safely and responsibly; placing limitations on the amount of drinks sold in one transaction; providing for security measures and the requirement for Alcohol Management Plans to name a few.

However, academic research shows that price and age are two areas that can make the biggest difference to alcohol related harm and these are outside of the control of local government and beyond the remit of the Act. Therefore there will always only be limited ability to truly minimise harm caused by alcohol consumption.

11. To what extent, if any, do you consider that achievement of the object of the Act may have been affected by the Covid-19 pandemic?

During original lock downs the majority of premises were not open so therefore the object of ‘the sale and supply should be undertaken safely and responsibly’ is largely not applicable. The supermarkets continued to control supply and abide by the rules and regulations of the Act. Customers purchasing habits largely changed to reflect the inability to purchase alcohol elsewhere (bottle stores and on licences).

Customers consumption habits moved to be in the home rather than in on licence premises.

The pandemic has required many premises to diversify their businesses or have a larger online presence. However Council does not have evidence of whether the pandemic has had an impact on the achievement of the object of the act.

12. What changes or trends in licensing have you seen since the Act came into force?

Things have largely stayed the same other than administration processes. There has been a slight increase in objections from the public resulting in public hearings.

13. What changes to practices and procedures under the Act would you find beneficial?

There are many areas of the Act that are not practical or create a grey space and are open to interpretation and therefore create differences in licensing around the country. The main areas of concern where change is required that would be beneficial are:

- **Section 32 – off licences**
 - There are issues with more and more online sales occurring – online shops or online shops within shops. A website that allows other stores to sell their alcohol products online through their website and the primary site gets a percentage or commission. Therefore it is a technical sale and both parties should have a licence.
 - We are seeing this more and more with sites. The Act needs to accurately reflect what is and isn’t allowed when it comes to online stores and who has to hold the licence / what type of licence is required.
 - The needs to be a definition of “Shop” and for it to include online stores

Section 58 – alcohol sold in supermarkets

- Clarification on whether 0% alcohol can be sold in the alcohol area – strict reading of the act says no – but many do. Clarification is required. For example 0% spirits do not appear to be covered under the Section 114 amendment.

Sub part Two - Local Alcohol Policy

- Frustration over the time it takes to have a local alcohol policy adopted and that the process is seen as complicated, litigious and costly.
- The appeal process seems to support the Supermarket giants and some chain alcohol stores, who have the time, money and resources to appeal and provide detailed evidence. The system was set up to provide more input for local people and communities, and it has not done so. Local voice has little weighting when it comes to appeal decisions. Evidence is not always available and therefore it is difficult to support a policy position.
- Clarification regarding the review of a LAP – if no changes are made is a SCP required?

Section 112 / 114– Display and promotion of alcohol – Exposure

- The Act should determine whether end of aisle displays and sales should or should not occur to prevent ongoing issues with Supermarkets and differences around the country.

Section 149 – Duration of Special licenses

- Specific rules in relation to how many Special licence dates there can be in a series for one special licence. The regulations (fees) indicate 12 but this needs clarification in the Act. This would prevent differences around the country.

Section 217 – Managers Certificate

- This section indicates that a manager’s certificate authorizes the holder to manage any premises – but many inspectors put undertakings on certificates stating they can only manage certain type of premises – conditions are also not allowed on managers certificates – clarity on this would be beneficial.

Section 224 a (ii) - Renewal of Managers Certificate - employed

- Case law indicates that a manager has to be employed. However two sections of the Act (i.e. 22 a i/ ii) appear to contradict this. Also club managers are also not strictly employed they are often volunteers. Clarification required on these issues.
