Application form for registration of a Food Control Plan or National Programme

Background

The Food Act 2014 came into force on 1 March 2016. The Act applies to all new food businesses.

The Act brings in the following new food safety measures:

Food Control Plans

A food control plan sets out the steps a business making or selling higher-risk foods needs to take to make safe food. It is used to identify food safety risks, and to show how they're being managed. National Programmes

Verification of Food Control Plan or National Programme

Fees

Fees for registration and verification are based on the time taken to undertake these activities. Fees for verification work are invoiced <u>separately</u> once the verification has been undertaken. Collection of Information

Pursuant to Principle 3 of the Privacy Act 1993, we advise that:

- This information is being collected for the purpose of registering under the Food Act 2014;
 and
- The recipient of this information, which is the agency that will collect and hold the information, is Hastings District Council, Private Bag 9002, Hastings 4156; and
- Some of the information collected will be displayed on a public register; and
- The collection of information is authorised under section 53 or section 83 of the Food Act 2014, which ever applies. The provision of this information is necessary in order to process an application for registration under either section 53 or section 83; and
- The supply of this information is voluntary; and
- Failure to provide the requested information is likely to result in a return of this application form to the applicant, and may ultimately result in a refusal to register, in accordance with section 54 and 57 or section 84 and 87, of the Food Act 2014, which ever applies; and
- Under Principles 6 and 7 of the Privacy Act 1993, you have the right of access to, and correction of, any personal information that you have provided.

Collection of Official Information

- All information provided to the Ministry for Primary Industries is official information and may be subject to a request made under the Official Information Act 1982.
- If a request is made under that Act for information you have provided in this application, the Hastings District Council must consider any such request in accordance with its obligations under the Official Information Act 1982 and any other applicable legislation.

WATER SERVICES BYLAW

Please read the following information and contact the Trade Waste Officer at the Hastings District Council if you have any questions (06 871 5000).

How does the Bylaw affect your business?

As a business preparing and selling food from your business premises, you will be discharging Trade Waste that contains oil and grease (fat).

The Building Act (G13) stipulates that all premises, other than domestic dwellings, carrying out trade that is likely to result in oil or grease in the waste discharge must install a grease trap.

Schedule B in Chapter 7 of the Bylaw lists the limits that are in place for various characteristics in the wastewater, including oil and grease.

The limit in the Bylaw for 'floatable oil and grease' is **30 mg/Litre** (30 gms per 1000 Litres of wastewater).

The limit in the Bylaw for 'total oil and grease' is **100 mg/Litre** (100 gms per 1000 Litres of wastewater).

The discharge becomes Controlled Wastewater if the amount of any of the characteristics in the discharge are greater than the limits in the Bylaw and the discharger must have an Approval to Discharge Controlled Wastewater.

Food businesses (Bakeries, Restaurants, Cafes, Takeaway shops etc.) will have a level of oil and grease in the discharge that is higher than the Bylaw limit. This means that the discharge should have an Approval to Discharge, except HDC decided to classify these types of businesses as permitted discharge **if** the business has a grease trap installed. Correctly sized grease trap will remove most of the oil and grease from the discharge.

You can find out more about types of grease traps and information about sizes required.

Characteristics refers to the solids, oil and grease, volume, metals etc. present in the wastewater.

Floatable oil and grease (commonly referred to as fat) is any oil and grease that separates out of the wastewater and floats to the top when it cools.

Total oil and grease (commonly referred to as fat) is all oil and grease present in the wastewater, whether it is floating or emulsified by cleaning chemicals or additives.

Approval means a written approval, issued by the Hastings District Council.

Permitted discharge means a discharge that does not need to have an Approval to Discharge.

Grease trap is a device that removes oil and grease from wastewater. <u>It must be sized</u> <u>correctly</u> to be effective enough to meet the limits in the Bylaw.

Points from the Bylaw

Schedule B of Chapter 7 of the Hastings District Council Consolidated Bylaw applies to all food related businesses. The Key Points to note are:

- There are two categories of Trade Waste: Controlled Wastewater and Permitted discharge.
- Food businesses are technically 'Controlled Wastewater' but are regarded as 'permitted discharge' **if** they have a suitable grease trap installed.
- Anyone discharging Controlled Wastewater, without Approval, commits an offence under the Bylaw. The exception to this is a food business that has a suitable, correctly sized grease trap in place that makes the discharge 'permitted' discharge.
