VARIATION 3: HOWARD STREET RESIDENTIAL REZONING

In accordance with Schedule 1 of the Resource Management Act 1991, the Hastings District Council gives notice that Hastings District Council has prepared the following variation to the Proposed Hastings District Plan.

Description of Variation:

The proposal is to rezone 22 hectares of land from its current Plains zone to a General Residential zone located between Howard Street and Havelock Road and adjoining the existing Residential land on the southern side of Hastings city. The rezoning area includes the Parkvale School (1.8 hectares) and a proposed stormwater detention area (1.2 Hectares).
